
## Fund Description

The sub fund's objective is to seek, over the recommended investment period of five years a performance linked to international equity markets, mainly European, within the framework of discretionary management.

Management is exercised through positions in European listed equity markets selected on a discretionary basis.

The sub fund is not managed in relation to a benchmark indicator but may for retrospective comparison purposes compare its performance with that of the reference index DJSTOXX Small 200 (dividends reinvested).
